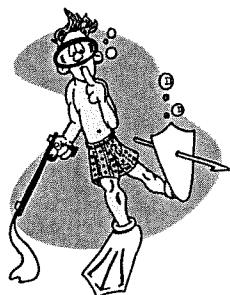
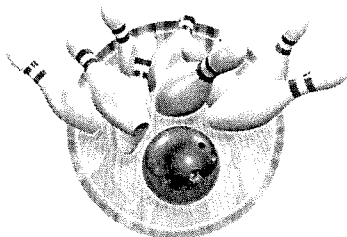

Coldwater Summer Youth Workers Biography

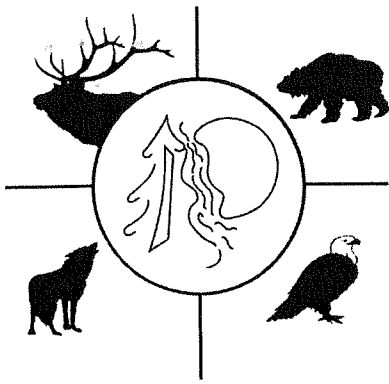
Hello Parents and Children's,
